Dog Agreement

Please be aware that failure to adhere to these Rules may result in you being required to leave the Park immediately without refund or recourse:

1. The dog owner must contact the Park directly, in advance of arrival to request permission to bring their dog into the park. Upon arrival it is park management's discretion whether the dog to enter the Park. Upon permission by park management, the dog owner must then agree to and sign these rules.
2. Without exception, the dog must be leashed at all times whilst not appropriately contained within your accommodation. A leash must be no more than 2 metres in length. No alternate form of enclosure such as dog runs are to be set up.
3. The dog must be supervised at all times and must never be left unattended unless securely tied up at your site.
4. For health and safety reasons, dogs are not allowed in common areas of the Park including reception, recreation room, amenities blocks, playgrounds, or other.
5. For health and safety reasons dogs must not be washed or cleaned anywhere within the Park. Dog related accessories such dog blankets should not be washed or cleaned using the facilities of the Park.
6. Dog owners are 100% responsible for picking up their dog's waste in a sealed plastic bag and disposing of it in a rubbish bin. Bags are available around the Park.
7. Dog owners are personally responsible for any and all personal injuries and/or property damage or losses in relation to any actions by or because of their dog.
8. Park management reserves the right to evict any guest whose dog is deemed noisy, disruptive, aggressive or the subject of complaints from other guests.
9. It is the dog owner's responsibility to control and manage their dog.
