#### Written Submissions at the Hearing

- 1. All parties should bring to the Hearing at least five (5) hard copies of additional written submissions and accompanying documents (i.e. photographs, plans). Copies of original submissions are not needed.
- 2. Written material presented at the Hearing should be two-hole punched and stapled (not bound).
- 3. Submissions (preferably in MS Word) should be emailed to the Panel after the Hearing at planning.panels@delwp.vic.gov.au.
- 4. Submissions and material presented at the Hearing including PowerPoint presentations are public documents and may be made available to other parties.

#### **Exchange of Expert Witness Reports**

- 5. Expert witnesses reports must comply with the Planning Panels Victoria Guide to Expert Evidence (http://www.planning.vic.gov.au/panels-and-committees/planning-panel-faqs).
- 6. Expert witness reports should not refer to any individual submitter by name. If necessary, submitters may be referred to by submission number.
- 7. A copy of any expert witness report received must be made available on Council's website and at its office.

#### Information to be supplied by Council

- **8.** Council must circulate to all parties on the distribution list its 'Part A Submission' by **2.00pm on Monday 20 November 2017** (both Hard and Electronic copies). This should include:
  - Background to the Amendment.
  - b. Chronology of events.
  - c. Strategic context and assessment, including responses to the relevant elements of:
    - Ministerial Direction No 13 (Requirements to be met)
    - Planning Practice Notes 11, 36 and 53
    - Victorian Coastal Strategy
    - Guidelines for Coastal Management Authorities: Assessing development in relation to sea level rise (DSE) (2012)
    - Guidelines for development in flood prone areas (WGCMA) (2013)
    - Clause 21.07-1 (Climate change), strategy 1.2
    - Clause 21.15-9 (Venus Bay), the "development prerequisites" under the fourth "settlement" strategy.
  - d. Changes to the Amendment or planning permit documentation proposed as a result of the issues raised in submissions.

Note: At the Hearing, Council's 'Part A Submission' will be taken as read by all parties. Council should allow time on Day 1 for questions of clarification from the Panel.

- 9. At the Hearing, Council must address the following issues through its 'Part B Submission':
  - a. Responses to issues raised in submissions, including responses to each point of objection in the West Gippsland CMA written submission.
  - b. Responses to evidence tabled.



- c. Advice on any discussions with VicRoads about the security of or any upgrades to the Inverloch Venus Bay Road.
- d. Advice on any opportunities to improve accessibility between Venus Bay and Tarwin Lower as recommended in the South Gippsland Housing and Settlement Strategy (2013).
- e. Advice on the potential lot yield from the areas being zoned LDRZ and TZ.
- f. Its final position on the Amendment.
- 10. Council must supply PPV with the following by 2.00pm on Monday 20 November 2017:
  - a. Venus Bay Urban Design Framework: Settlement Background Paper (2006)
  - b. Any background or supporting documentation provided to Council by the proponent in support of the application.

#### Information to be provided by West Gippsland CMA

- West Gippsland CMA must circulate the following information by 2.00pm on Monday 20 November 2017 (both Hard and Electronic copies) in accordance with the attached Distribution List.
  - a. a plan showing the general extent and depths of predicted inundation along the Inverloch-Venus Bay Road referred to in its written submission.
  - b. Advice on the source and currency of the flood mapping relied on in the submission, and whether there are any plans to review or update the mapping or modelling.
