## **Panel Directions**

South Gippsland Planning Scheme Amendment C90: Housing and Settlement Strategy

#### **Directions following Directions Hearing**

- 1. By Monday 17 September 2018, Council must provide the Panel and parties with:
  - a. a copy of all relevant correspondence between Council and referral authorities pertaining to the Amendment
  - b. all Framework Plans forming part of the Amendment, identifying how they are proposed to be integrated with the policy provisions or controls
  - c. key documents relating to the recently completed planning scheme review (in electronic format only at this stage).
- 2. By **Friday 12 October 2018**, Council must provide the Panel and parties with an update on the status of discussions/correspondence:
  - a. with the Country Fire Authority (CFA) and any further assessments or proposed changes to the Amendments in respect of bushfire risk and updated bushfire policies in the South Gippsland Planning Scheme
  - b. with the West Gippsland Catchment Management Authority (CMA) and any further assessments or proposed changes to the Amendments in respect of flooding, overland flows, storm surge or sea level rise risk
  - c. with DELWP in respect of opportunities to use VPP tools to give effect to the proposed Amendment, such as:
    - i. reference vs background documents
    - ii. existing or new provisions pertaining to Incorporated Documents or other planning scheme mechanisms (such as a schedule to the Restructure Overlay)
    - iii. the preferred location of Framework Plans and Restructure Plans within the planning scheme
    - iv. the approach to proposed changes to Local Planning Policies, and the like.

#### Written Submissions at the Hearing

- 3. All parties should bring to the Hearing at least six (6) hard copies of additional written submissions and accompanying documents (i.e. photographs, plans). Copies of original submissions are not needed.
- 4. Written material presented at the Hearing should be two-hole punched and stapled (not bound).
- 5. Submissions (preferably in MS Word) should be emailed to the Panel after the Hearing at <u>planning.panels@delwp.vic.gov.au</u>.
- 6. Submissions and material presented at the Hearing including PowerPoint presentations are public documents and may be made available to other parties.

## **Exchange of Expert Witness Reports**

- 7. Expert witnesses reports must comply with the Planning Panels Victoria Guide to Expert Evidence (http://www.planning.vic.gov.au/panels-and-committees/planning-panel-faqs).
- 8. Expert witness reports should not refer to any individual submitter by name. If necessary, submitters may be referred to by submission number.
- 9. Expert witness reports must be circulated by 2.00pm on Friday 2 November 2018 in accordance with the attached Distribution List.



- 10. A copy of any expert witness report received must be made available on Council's website and at its office.
- 11. The Panel must be provided with an 'unlocked' copy of any document circulated.

#### Information to be supplied

- 12. Council must circulate to all parties on the distribution list its 'Part A Submission' by **2.00pm** on Friday 2 November 2018. This should include:
  - a. Background to the Amendment
  - b. Chronology of events
  - c. Strategic context and assessment
  - d. An outline of how the Restructure Overlay Plans and Framework Plans were formulated and what considerations were taken into account
  - e. An outline of the process by which Port Welshpool came to be included in the Amendment, including relevant DELWP documentation
  - f. Details of how the Restructure Overlay and the associated proposed Incorporated Document are intended to operate for affected land, including an analysis of how/whether other provisions of the planning scheme such as the underlying zone provisions, overlay controls and particular provisions would continue to apply
  - g. Identification of the issues raised in submissions and a response
  - h. Any changes to the Amendment documentation proposed as a result of the issues raised in submissions.

Note: At the Hearing, Council's 'Part A Submission' will be taken as read by all parties. Council should allow time on Day 1 for questions of clarification from the Panel.

- 13. At the Hearing, Council must address the following issues through its 'Part B Submission':
  - a. A summary of the key issues raised in submission
  - b. Response to evidence tabled
  - c. Final outcomes from the discussions with the CFA and CMA
  - d. Its final position on the Amendment.
- 14. For the start of the Hearing, Council should arrange for:
  - a. A map showing the location of submitters by submitter number. This map:
    - i. must not show submitter names
    - ii. does not need to show the location of pro-forma submitters
    - iii. must not be placed on the internet or replicated in any report.
  - b. Appropriate aerials and plans at large scale with zoning and overlays also shown
  - c. Access to Council's GIS maps/system for the duration of the Hearing
  - d. A suggested itinerary for the Panel's site inspection of properties that are identified in submissions in respect of the Amendment and to use consistent reference to these properties (by number, location etc) when making its submissions.
