### Application Considerations:

An exemption can only be granted pursuant to Building Regulation 280 for new class 10 buildings on farming land which is to be used for farming purposes. Class 10 buildings are typically non-habitable structures used for storage, such as hay and machinery storage sheds. Farm buildings used for processing, packaging, assembly, repairing, finishing or cleaning goods for trade sale or gain (such as dairies, packing or processing buildings/warehouses and commercial activity uses) cannot be classed as class 10 buildings and are not eligible for this exemption. Sheds over 200m<sup>2</sup> in floor area will not be approved for this exemption. Sheds with excessive engineering designs may not be considered for this exemption. Each application is assessed on a case by case basis. If approved the class 10 building must be erected in within 12 months of the approval date. Hobby farms will not be considered.
