Firstly thank you for taking my call earlier in the evening

Please see below a summary of what we discussed which can be used for reference and submitting to council if need.

After many years of waiting (since 2013) it was put forward in February's Council meeting under item 5.7, the proposal for the extension of Elphicks Rd, Foster to named Stapleton Lane in memory of Private Stapleton who died at Gallipoli 1915, and all other soldiers who have served our country.

The name Stapleton was put forward after consultation with the Foster RSL, in the lead up to the ANZAC Centenary about the opportunities that a newly constructed road would allow. Over 100 Oak Trees were planted along the length of the Rd, creating a "Avenue" of honor for fallen soldiers from WW1 and WW2. Unfortunately the biggest drama in the whole process has been the amount of time the Shire has taken in processing the naming of the road. The original plan was to have road officially opened as part of the centenary celebration in 2015, but unfortunately that time has come and gone.

I was shocked when I was reading the minutes of June's meeting at the swap that occurred. I agree with the 2nd submission for the inclusion of the Anzac emblem be included in the sign, in regards to the 1st Hendra's may have owned land in the general Foster area but have no connection to land in question all land adjoining the new road up until 2008 was owned be Elphick family since the end of WW1.

With Private Stapleton being the 1st enlistee from the Foster district to be killed during World War 1, it is fitting that the avenue be named in his memory.

Please find attached letters from the Foster RSL and Foster Historical Society supporting the reinstatement of the name Stapleton.

I am also concerned about the unintentional association that 'Hendras Lane' may have with the Hendra Virus, a deadly virus predominantly effecting horses.
