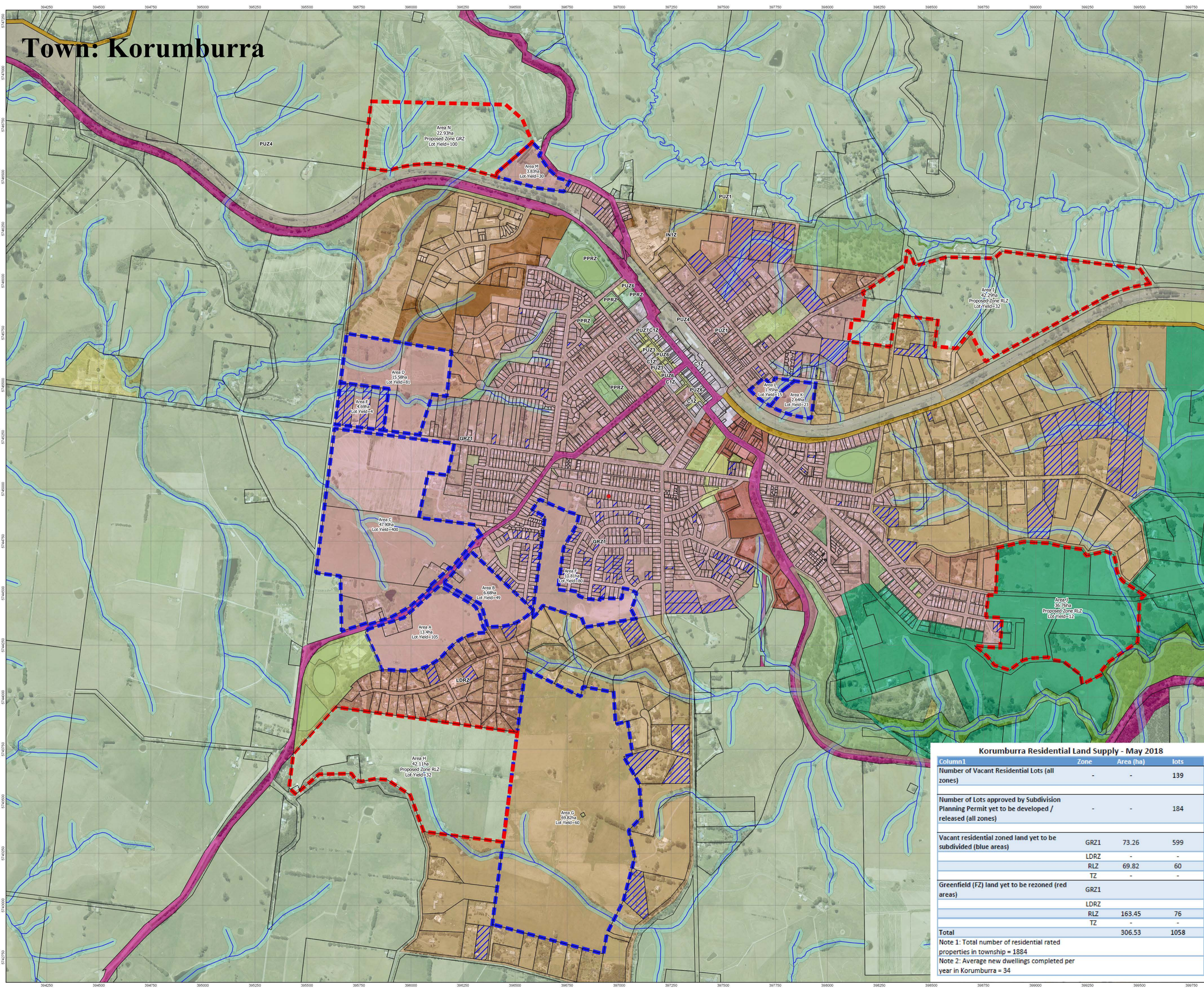

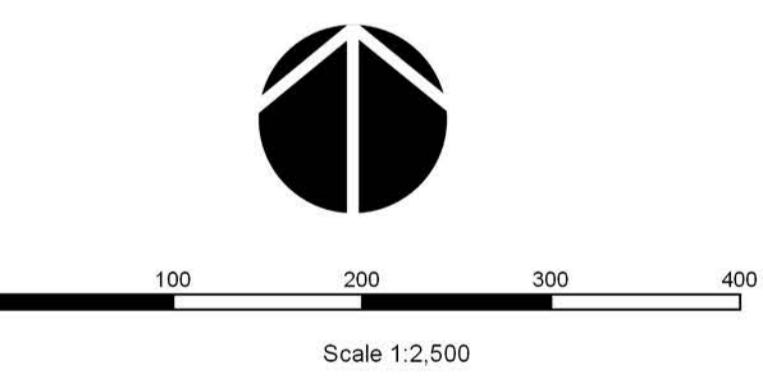
- Residential Lot Yield Calculations**
- General Residential Zone 1 (GRZ1) & Township Zone (TZ) = 10 lots per Ha.
 - Low Density Residential Zone (LDRZ) = 4 lots per Ha (sewer) & 2 lots per Ha (no sewer)
 - Rural Living Zone = 8 lots per 10ha.

Lot yields are estimates only. Yield estimates have been reduced by the presence of waterways, steep topography, native vegetation and other factors.

The lot yield calculations do not imply that Council will approve a subdivision or the rezoning of land identified in the map

Lots identified as a 'vacant Residential Lot' may include lots that form part of a larger land ownership (tenement) that may contain a dwelling.
