Beveridge Williams recently approached ACHM on your behalf to provide advice to you in regard to any Aboriginal Cultural Heritage issues or triggers associated with several lots on Jumbunna Road, Korumburra.

The land in question is:

## **Aboriginal Cultural Heritage**

The Aboriginal Heritage Act 2006 and the Aboriginal Heritage Regulations 2007 require that a cultural heritage management plan to be completed if both of the following conditions are met; namely:

- 1. The activity being contemplated (i.e. the type of development) is a 'high impact activity' (as defined in the Regulations), and
- 2. All or part of the 'activity area' is in an 'area of cultural heritage sensitivity' (as defined in the Regulations).

## Findings

Regardless of the type of activity being planned, the land in question is <u>NOT</u> in an 'area of cultural heritage sensitivity' as defined in the Aboriginal Heritage Regulations 2007, so therefore the combined triggers are not met. A mandatory Cultural Heritage Management Plan is NOT required in this instance. See map on the following page.

## Harming Aboriginal Site(s)

Although a Cultural Heritage Management Plan is not legally required in this case, it is still an offence (carrying large penalties) under the Aboriginal Heritage Act 2006 to harm Aboriginal cultural heritage items or places on the subject land. To ensure that there is no legal liability upon developing the land, an inspection is recommended by a qualified archaeologist prior to any ground disturbing works.

In conclusion, there are no statutory triggers requiring a Cultural Heritage Management Plan for this land and/or any development associated with it.

The Local Government Authority has no grounds to require a cultural heritage management plan as a planning condition.

We still urge caution however, as harming an Aboriginal site is an offence under the Aboriginal Heritage Act 2006.
