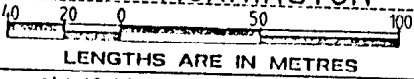

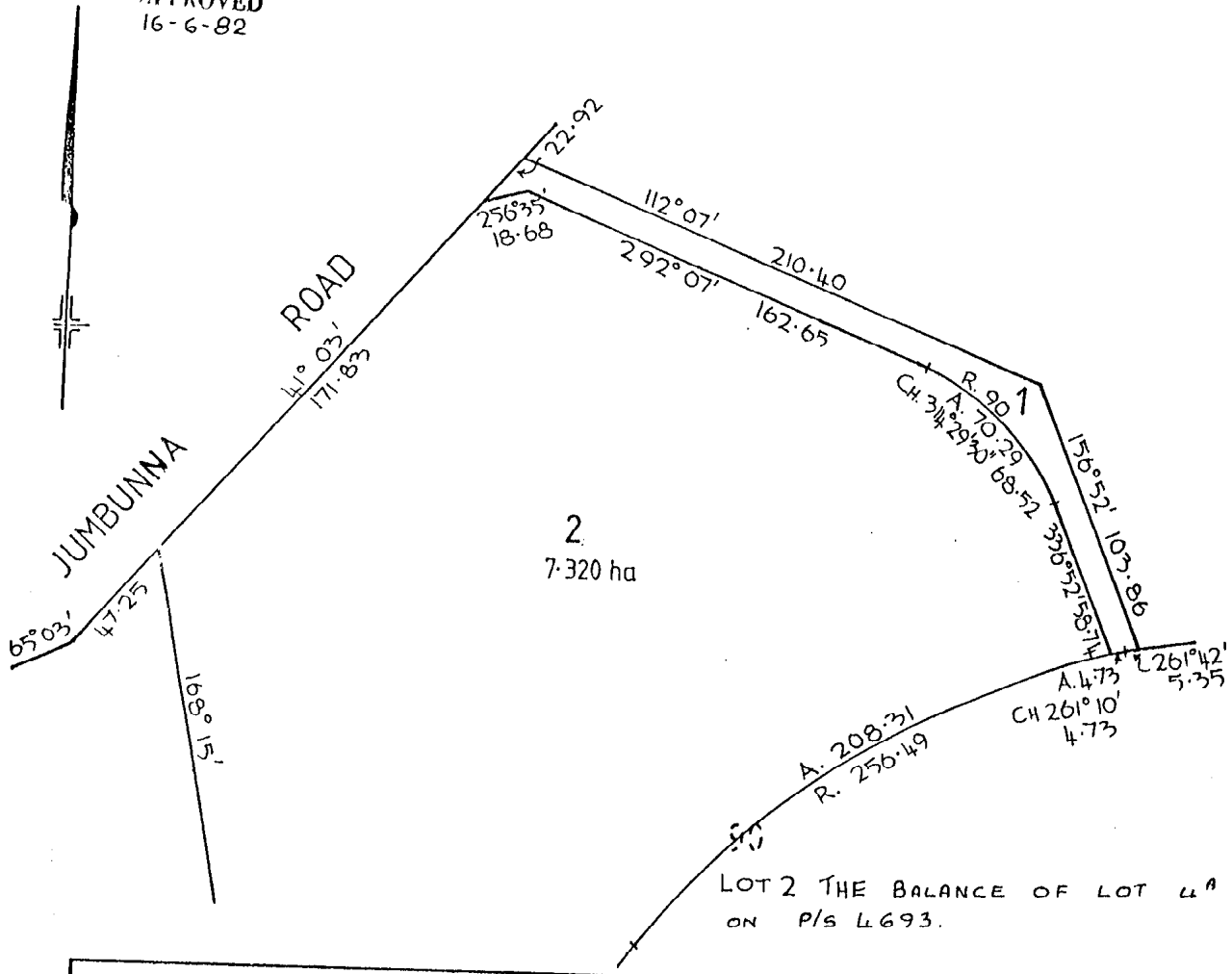
PLAN OF SUBDIVISION OF: PART OF CROWN ALLOTMENT 90	APPROPRIATIONS
