Submitters (or Representatives) will be heard at an Open Hearing of Council in the Council Chambers, Michael Place, Leongatha at 10.45am on 22 May 2019 for the Revised Council Plan 2017-2021 and Proposed 2019/20 Annual Budget and an Open Hearing at 2.15pm for the Proposed Rating Strategy 2019-2022.

Council will consider and decide on all the submissions at a Special Meeting of Council in the Council Chambers, Michael Place, Leongatha at 11.00am on Wednesday 29 May 2019. Please note copies of submissions (including submitters' names and addresses) will be made public in Agenda and Minute documents at the Open Hearing of 22 May 2019 and the Special Meeting of Council 29 May 2019.

Council is also required to make submissions available for public inspection for a period of 12 months. Following consideration of the submissions, Council may amend or not amend the Council Plan, Annual Budget or Rating Strategy.
