	Trotman Court LEONGATHA	Formerly known as Tilly Court [part section]. The road traverses east for approximately 110 metres off Louise Simon Court.
	Slade Court STONY CREEK	The road traverses in a north-east direction for approximately 170 metres off Main Street
	Simpson Street FOSTER	Formerly known as McDonald Street East. The road traverses west from Reservoir Street and is a continuation of the existing Simpson Street
	Stagecoach Track MOUNT BEST	The road traverses south from Foster-Mt Best Road
