Council recently adopted its Council Plan 2020-2024 and Annual Budget 2020/21 which will determine our focus for the next twelve months to four years.

At the forefront of the Annual Budget is the \$2M COVID-19 Community Support Package and a \$39.63M Capital Works Program.

The \$2M COVID-19 Community Support Package will focus on providing support to community groups and businesses who need assistance after experiencing adverse affects caused by the virus.

The \$39.63M Capital Works Program is one of the largest programs undertaken by Council in recent years. A number of projects are included within this program which will improve the livability of South Gippsland such as Bair Street, Korumburra Streetscape, Korumburra Community Hub, Great Southern Rail Trail extension and Mirboo North Pool Befurbishment.

Our objectives under the Council Plan are United Shire, Economic Prosperity, Integrated Services and Infrastructure and Customer Focused Organisation. We look forward to partnering with our community and local businesses to ensure we can reach these goals.
