

Pension Concession Eligibility Check Form

This application is not transferable. If you move, you will need to complete a new application.

If you currently hold a Pensioner Concession Card (PCC), Gold Card TPI (Totally and Permanently Incapacitated) or a Gold Card War Widow (includes widowers), you may be entitled to receive a concession on your rates for your principal place of residence.

By completing and signing the form on the next page, Council will then be able to perform a standard eligibility check using Centrelink's Confirmation eServices Portal to verify that you are an eligible cardholder.

Once these details are confirmed, we will amend our rate records so that moving forward, you will receive the concession reduced rates. We will respond via an amended rate notice or letter depending on the outcome of the check.

Please complete and return this form to Council via one of the below methods and we will be able to process your form accordingly.

Ineligible Concession Cards

Health Care and Seniors Cards are not eligible for this concession. The EDA (Extreme Disablement Adjustment) and POW (Prisoner of War) Cards, and the general Gold Card are also ineligible.
