South Gippsland Shire Council News Keeping Our Community Immunised

Council's Immunisation team has been working tirelessly during the COVID-19 pandemic to ensure that our community has access to vital immunisations in a safe environment.

It is important to not delay scheduled immunisations due to the pandemic to ensure that our community stays healthy and can fight other illnesses.

Our next immunisation session will be held on Wednesday 7 October in Memorial Hall, Leongatha from 9.30am to 12.30pm.

As has been the case since the pandemic started, patients will need to make an

appointment for the session and wear a face covering unless they have an identified exemption.

At our immunisation sessions we continue to:

- Enforce social distancing.
- Complete pre-entry questionnaires to ensure patients (to their knowledge) haven't been in contact with COVID-19 and are well on the day.
- Conduct temperature checks via a contactless thermometer.
- Ensure adequate hand sanitisation.

REVISED LOCAL LAW NO.2 2020

Council has endorsed a Revised Local Law No.2 2020 Processes of Municipal Government (Meeting Procedures and Common Seal) in accordance with ss.125 and 127 of the *Local Government Act 1989*. Numerous sections have been repealed, following the adoption of the Governance Rules 2020. Remaining sections have been retained and/or amended to align with current legislative requirements. Copies of the Revised Local Law No.2 2020 and Community Impact Statements are available for inspection on Council's website and hardcopies can be mailed by contacting Customer Service before Friday 23 October. A person proposing to make a submission under s.223 of the Act must do so by 5.00pm 29 October 2020. Late submissions will not be considered. Submissions must be addressed to the Chief Executive Officer, South Gippsland Shire Council. Copies of submissions, including submitters' names, will be made available in open agendas. Submitters concerned with the use and disclosure of their personal details can advise Council Business by using the submission email before 5.00pm on Thursday 29 October 2020. Any person lodging a submission may request to be heard in support of their submission, or to be represented by a person specified in their submission, at an additional Council Meeting at

11.00am on Wednesday 18 November 2020. Attendance at any public hearing or open meeting is subject to actions required under Council's Business Continuity Plan relating to COVID-19. Email submissions are preferred via submission@southgippsland.vic.gov.au Alternatively, submissions will be accepted in writing addressed to: Chief Executive Officer, South Gippsland Shire Council, Private Bag 4, Leongatha, VIC 3953. Following consideration of the submissions, Council may amend or not amend the Proposed Local Law No.2 2020. For further enquiries contact our Council Business Team.
