South Gippsland Shire Council News Home-Based Business Grants Open!

South Gippsland Shire Council's COVID-19 Home-Based Business Grants are now open.

The grants are open to home-based businesses in South Gippsland with an annual turnover between \$25,000 and \$250,000 that have experienced a downturn as a result of COVID-19.

The grants are part of Council's \$2M Community Support Package and are aimed at small food producers, home-based health and beauty services and creative and training businesses. Eligible businesses will receive a grant of \$1,000 (ex GST) that can be spent on essential business fees, services or materials.

South Gippsland Shire Council's Chair Administrator, Julie Eisenbise expects that the

funding will provide much-needed support for many home-based businesses.

"Home-based businesses have been significantly impacted by COVID-19 and many have only received limited financial support due to restrictions on government funding. We hope that these grants will provide a small amount of relief and help business owners to revitalise their businesses now COVID-19 restrictions are easing," said Ms Eisenbise.

The Home-Based Business Grants open are open until 5.00pm Friday 20 November or until the \$100,000 allocation is exhausted. Applications will be assessed as they are received and awarded when the assessment process is complete. To apply, please visit: www.southgippsland.vic.gov.au/covidsupport

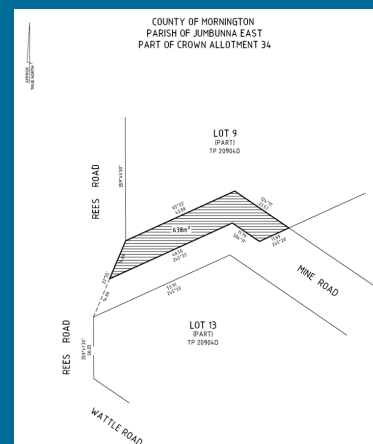

PROPOSED ROAD DISCONTINUANCE AND SALE



Council proposes to commence statutory procedures to discontinue part Myrtle Street and part Mine Road Jumbunna being part crown allotment 34 Parish of Jumbunna East, shown in plan above, with an area of 638m² and sell the land to the abutting land owner of 27 Rees Road Jumbunna, for not less than a valuation which is made not more than six months prior to the sale,

pursuant to sections 206, 207A and 223 Schedule 10 clause 3 of the *Local Government Act, 1989*. A person may make a submission to this proposal. Submissions are to be received no later than 5.00pm Wednesday 2 December 2020 and addressed to the CEO, South Gippsland Shire Council, 9 Smith Street (or Private Bag 4), Leongatha VIC 3953. Any person making a submission is entitled to be heard in support of the submission. If a person or a representative wishes to be heard in support of the submission they must state this in their submission. Copies of submitter's name and address may be disclosed at any public Council meeting or special committee meeting at which the proposal will be considered. If no submissions are received the proposal will be implemented.
