The Bair Street Project is progressing well with the first section of asphalting completed last week.


Overhead powerlines have been removed, new streetlights have been switched on and the first sections of the new footpath have been installed.

A new pedestrian (zebra) crossing is now operational in Bair Street between McCartin Street and Lyon Street.

This crossing replaces the old signalised crossing and is the first of four zebra crossings that will be installed in Bair Street as part of the project.

If you are driving along this stretch, please note that the normal pedestrian crossing rules apply. You will need to give way to any pedestrian on the crossing and approach the crossing at a speed that would enable you to stop safely.

## **AMENDMENT C124 - PLANNING PERMIT** APPLICATION

This Amendment proposes the rezoning of 6A Warralong Court, Leongatha and 15 Old Waratah Road, Fish Creek from Public Park and Recreation Zones to General Residential Zone (schedule 1) and Township Zone respectively.
