COVID-19 slowed down not only our national economy, but our local economy too. Businesses were hit hard with numerous lockdown stages and changing restrictions that added a level of complexity to how many businesses operated. Without cash flow, businesses are not able to survive.

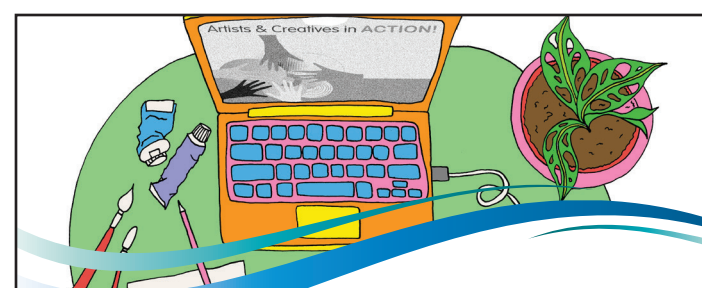
At Council, we knew that being a significant purchaser of local goods and services, we had to look at how we compensate businesses for what they have provided us.

To help our local businesses, we made a change to how we process payments to keep the cash moving.

Since the start of COVID-19, we have increased our number of payments within seven days of receipt of invoice from 49 per cent to 85 per cent, and 95 per cent paid within 14 days.

This could not have been achieved without our Accounts Payable team, who made this a clear focus.
