Green Waste Amnesty to assist the clean-up

South Gippsland Shire Council is providing a green waste amnesty from Thursday 17 June to Wednesday 30 June inclusive.

The amnesty, which was announced on Wednesday 16 June, allows residents who reside in or own a property in South Gippsland to dispose of green waste at all of Council's transfer stations at no cost.

It is hoped that this will help residents and ratepayers to clear fallen trees and debris from their

properties following last week's weather event.

However this does not include branches that exceed 300mm in diameter, tree stumps, coated timber, and some specific species.

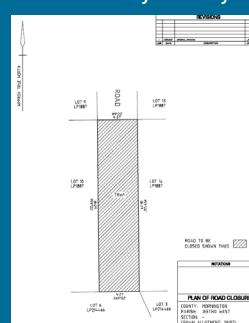
PROPOSED ROAD DISCONTINUANCE

Part Lane Way – Rear of 10 Clarence Street Loch

Council at its ordinary meeting held 16 June 2021 proposed to commence statutory procedures to discontinue part of a lane way at the rear of 10 Clarence Street Loch, being part crown allotment 30 Parish of Jeetho West (shown in the plan below) with an area of 78m² and sell the land to

the abutting owner of 10 Clarence Street Loch, for not less than a valuation received within six months prior to the sale, pursuant to s.206, s.207A, s.223, and Schedule 10 clause 3 of the Local Government Act 1989.

A person may make a submission to this proposal. Submissions are to be received no later than 5.00pm Wednesday 21 July 2021 and addressed to the CEO. Any



person making a submission is entitled to be heard in support of the submission. If a person or representative wishes to be heard in support of the submission, they must state this in their submission. Copies of the submitter's name and address will be disclosed at any public Council meeting at which the proposal will be considered. If no submissions are received, the proposal will be implemented.
