## Administrators' Message



A Council Meeting week is always exciting as we make decisions that positively impact our community. This month, we saw a number of important matters come before Council.

This included the adoption of the Economic Development and Visitor Economy Strategies following the last phase of public consultation. These two documents are vital to South Gippsland and represent the enormous amount of work by the two Advisory Groups that oversaw their development. The groups are made up of local people with sectoral knowledge and expertise and people from outside the region whose subject matter knowledge and experience enabled them to add a fresh perspective within these groups. They have worked extremely well together and have overseen a process that has involved local people extensively throughout the development of these strategies.

Council is extremely grateful to the members of these two groups and thanks them on behalf of the people of South Gippsland for their commitment to the region and diligence in their work. We also applaud the many hundreds of people who contributed constructively through nearly 400 pieces of feedback that were collected and incorporated into the strategies.

Another important update from this week's meeting is the endorsement of West Gippsland Regional Library Corporation (WGRLC) moving to a not-for-profit organisation. This change effects not only South Gippsland, but also Bass Coast and Baw Baw Shire's as we all pool our resources within WGRLC to provide the best library service to all our communities.

We would like to assure our community that the services you know and love about our local libraries will not be negatively affected, in fact, we are confident that they will be improved with investment from sources that wouldn't be possible under the current structure. With this comes a name change from West Gippsland Regional Library Corporation to Myli – My Community Library to promote the delivery of library services beyond the existing West Gippsland region.

Our decision to support the transition to a not-for-profit model only takes effect once all three Council's adopt the same resolution. Bass Coast also made their decision this week and Baw Baw Shire Council is set to consider the proposal at their meeting next week.

Council also adopted our 2021/22 Priority Projects for advocacy including our Strategic Road projects. Projects that are not solely Council's responsibility such as the Wilsons Promontory Revitalisation Project have also been included due to their significant importance to our region.

## The projects include:

- 1. Korumburra Streetscape (Commercial Street);
- 2. Great Southern Rail Trail (GSRT) Railway Precincts Development (Leongatha and Korumburra);
- 3. South Gippsland Highway, Korumburra Realignment (Coal Creek bends);
- 4. Leongatha Heavy Vehicle Alternate Route Stage Two (Hughes Street);
- 5. Wilsons Promontory Revitalisation Project;
- 6. South Gippsland Urban Water Strategy;
- 7. Bass Highway Leongatha to Anderson;
- 8. South Gippsland Highway Grassy Spur Realignment;
- 9. Strzelecki Highway Crightons Hill Realignment; and
- 10. The Gippsland Tracks and Trails Project.
