2022 Kindergarten Enrolments

Parents have been waiting with bated breath for this time – first round offers for three and four-year-old kindergarten enrolments will be released soon.

Once the offers have been released, parents and guardians will have two weeks from the date of their offer to accept their place.

Allocations for next year's kindergarten places have been decided using the Victorian Government's central enrolment and priority access system, and every effort was made to give families their first preference.

The success of implementing the central enrolment scheme has ensured over 98 per cent of families will receive their first preference in a kindergarten, which is a great result for local families. Any child who did not receive their first preference are encouraged to accept their allocation as they will still be alerted if a position at a higher preference becomes available over the next few months.

AMAGORA

Over 530 kids were enrolled over a twomonth period from across South Gippsland, with Council's Early Years team working around the clock to support families with their applications.
