Community Grants: Round Two

Applications for the second round of South Gippsland Shire Council's Community Grants program are open from Friday 20 August.

To help support community groups with their applications, Council will be running two virtual information sessions on Monday 16 August at 11.00am and 7.00pm.

These sessions will brief those who wish to lodge a grant submission on what can and cannot be funded and provide a demonstration of the Smarty Grants online application process.

There are four grant categories available. These are:

- Minor Projects and Equipment Grant (up to \$5,000)
- Major Projects and Equipment Grant (up to \$10,000)

- Festival and Events Grant (up to \$10,000)
- Planning and Development Reports (up to \$10,000)

The Community Grants Program aims to support community initiatives, projects and events that support the South Gippsland region. Community Grants are open to community, volunteer and not-for-profit organisations.

This round of grants close Wednesday 20 October.
