Grant Funding Secured for Two Projects

South Gippsland Shire Council has recently received funding for two projects.

The Railway Precincts Development Project at Leongatha and Korumburra has been given a boost after receiving a \$3 million grant from the Federal Government's *Building Better Regions* Fund.

The project, which is costed at \$6 million, will support the Leongatha to Nyora rail trail extension and transform disused and neglected sites into attractive and usable public spaces.

The other grant application that was successful was for the Foster

Showgrounds Oval Upgrade and Irrigation project. It will receive \$150,000 from the State Government's Country Football and Netball Program.

This project will see the oval resurfaced, levelled, better drainage and a new automatic irrigation system installed. All of this work is anticipated to cost \$430,000, and importantly, will help to conserve water use and reduce operating costs.

Planning and Environment Act 1987 SOUTH GIPPSLAND PLANNING SCHEME Notice of the preparation of an amendment Amendment C125sgip

The South Gippsland Shire Council has prepared Amendment C125sgip to the South Gippsland Planning Scheme. The land affected by the amendment is 37 properties across the municipality and various road reserves.

The amendment proposes amend various provisions of the South Gippsland Planning Scheme to correct mapping anomalies, delete redundant controls, correct grammatical errors, make minor corrections to test, rezone farming land located at 293 Whitelaw Road (L1 PS313150L Parish of Korumburra), within the Korumburra settlement boundary to General Residential Zone and rezone Council owned township land located at 141-143 Jupiter Boulevard, Venus Bay (L22 LP52658 & L23 LP52658 Parish of Tarwin) to Public Use Zone 3 (Health & Community).

You may inspect the amendment, any documents that support the amendment and the explanatory report about the amendment, free of charge, at the following locations:

Any person who may be affected by the amendment may make a submission to the planning authority about the

amendment. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make. Name and contact details of submitters are required for council to consider submissions and to notify such persons of the opportunity to attend Council Meetings and any public hearing held to consider submissions. The closing date for submissions is 3 December 2021, 5.00pm. A submission must be sent to the South Gippsland Shire Council, Strategic Planning, Private Bag 4, Leongatha VIC 3953; or emailed to council@southgippsland.vic.gov.au with a reference to 'Amendment C125'. The planning authority must make a copy of every submission available at its office for any person to inspect free of charge for two months after the amendment comes into operation or lapses.
