## CEO's Message



We've had some wild weather yet again over the past week, with trees down and electricity cut off to some residents across our region. Over 77 roads were affected with trees down during the storm and as such, Council staff worked into the night and over the weekend to keep roads free of hazards.

The SES, as always, provided incredible support to the community by clearing trees and supporting people who had property damage due to the high winds we experienced.

Council staff worked collaboratively with the YMCA in Leongatha to provide 'power and showers' to impacted members of the community. Once again, our community houses became a focal point for supports to the community providing hot drinks, charging and relief supports.

AusNet worked to reinstate power across the Shire, with most locations being back on supply by last Thursday.

I would like to extend a huge thank you to every organisation and individual who has been involved in the response to this event. We can achieve so much when we all work together to support our community.

We welcomed the announcement this week from the Federal Government that a task force will be established to look into regional bank closures. We look forward to briefing our new Council on this matter so we can work with the community to ensure we can have a say on this important issue on behalf of South Gippsland.

To assist our community in getting properties cleared before the peak fire season begins, the annual Green Waste Amnesty has begun. Community members can dispose of green waste for free at Council transfer stations until 31 December 2021.

To improve the quality of the mulch produced, there are several species that cannot be accepted as part of the amnesty. These include Blackberry, Ragwort, Broom, Mirror Bush, Kikuyu Grass, Hawthorn, Cape Weed, Gorse, Blue Butterfly Bush and Pampas Grass. Species that are difficult to mulch properly are also not included in the amnesty, such as palm fronds, Yuccas, Cordylines and other related species. If any of these species are taken to a transfer

station they must be disposed of as general waste with applicable disposal fees applying. Alternatively, any of these species can be disposed of through the kerbside green waste collection service as this material is subjected to a different composting process.
