Green Waste Amnesty

To assist residents to remove potential fire hazards on their properties, Council is providing a Green Waste Amnesty until 31 December 2021.

Residents can dispose of their green waste for free at any of Council's transfer stations during this period.

The following species are not included in the amnesty: Blackberry, Ragwort, Broom, Mirror Bush, Kikuyu Grass, Hawthorn, Cape Weed, Gorse, Blue Butterfly Bush, Pampas Grass, Palm fronds, Cordylines, Yuccas and related species.
