Community Grants Round Two Open

Applications for Round Two of the Community Grants Program are now open.

Grants are available in the following categories:

- Minor Projects and Equipment Grant (up to \$5,000);
- Major Projects and Equipment Grant (up to \$10,000);
- Festival and Events Grant (up to \$10,000); and
- Planning and Development Reports (up to \$10,000).

Minor Project and Equipment Grants help to assist community groups with capital work projects, the purchase of equipment or the costs associated with adopting a new or improved service. Festival and Event Grants help to support locally run community events and Planning and Development Reports can help local groups to produce a business case or evidence of viability for community-based projects or facilities.
