Line marking on Stanley Street, Toora marked the completion of the Toora Streetscape project.

The Toora Streetscape project was a significant undertaking that involved footpath and drainage improvements, a new road surface and landscaping.

Parts of Stanley Street, Welshpool Road and Foster Road – Stage One were upgraded as part of the project, with the works completed by Council's amazing construction crews. The project was able to be completed thanks to funding from both Council and the Federal Government's Roads to Recovery Program.

The streetscape project builds on previous works that were completed in Stanley Street back in 2015.
