**Clause 46 of the South Gippsland Shire Council's General Local Law states:**

**46. Keeping animals**

- (1) An owner or occupier of a property must not, without a permit, keep or allow to be kept any more in number for each kind of animal than as set out in the following table:

<i>Type of animal</i>	<i>Maximum no. of animals allowed in residential, mixed use, commercial, township &amp; industrial zones as defined in the relevant planning scheme</i>	<i>Maximum no. of animals allowed in rural conservation &amp; rural living zones as defined in the relevant planning scheme</i>
