#### 1.7. DECLARATION OF CONFLICT OF INTEREST FOR COUNCILLORS

Any interest that a Councillor or staff member has deemed to be significant and has disclosed as either a direct or an indirect interest is now considered to be a conflict of interest. Conflict of interest legislation is in sections 77A, 77B, 78, 78A-D and 79 of the Local Government Act 1989 (the Act). This legislation can be obtained by contacting the Council's Corporate & Community Services Directorate (Council Business) or by accessing the Victorian Legislation and Parliamentary Documents website at <a href="https://www.legislation.vic.gov.au">www.legislation.vic.gov.au</a>.

An interest may be by close association, financial, conflicting duties or receipt of gifts. If a Councillor or staff member discloses any interest in an item discussed at any Council Meeting (whether they attend or not) they must:

- Complete a disclosure of interest form prior to the Meeting (forms are available from Council Business Department at South Gippsland Shire Council).
- Advise the Chair of the interest immediately before the particular item is considered (if attending the Meeting).
- Leave the Council Chamber or Meeting room while the item is being discussed and during any vote taken (if attending the Meeting).

The Councillor or staff member will be advised to return to the Council Chamber or Meeting room immediately after the item has been considered and the vote is complete.

Councillors should check the Minutes of the Council Meeting to ensure their disclosure is recorded accurately. Councillors are not required to disclose conflict of interest in relation to matters only considered at Meetings they do not attend. Detailed information is available in *Conflict of Interest – A Guide for Councillors – October 2012.* 

#### 1.8. DECLARATION OF CONFLICT OF INTEREST FOR STAFF

Sections 80B and 80C of the Local Government Act 1989 require members of Council staff who have delegated functions and/or provide advice to Council or a Special Committee to disclose conflicts of interest. If Council staff have written, provided information/advice or approved a Council Report and have a conflict of interest, it is the responsibility of that staff member to disclose the interest.

Guidance to identifying and disclosing a conflict of interest is contained in the Victorian State Government, Department of Transport, Planning and Local Infrastructure – *Conflict of Interest – A Guide for Council Staff – October 2011*.

# 2.1. S223 SUBMISSION - PROPOSED RATING STRATEGY 2019-2022 - OPEN HEARING

Corporate and Community Services Directorate

#### **EXECUTIVE SUMMARY**

At the Special Meeting of Council 20 March 2019, Council endorsed the Proposed 2019-2022 Rating Strategy and invited submissions from the public under s.223 of the Local Government Act 1989. Seven submissions were received, with five submitters requesting to speak at an Open Hearing. Refer to **Attachment [2.1.1]** for details on these submissions.

This Special Meeting is a formal 'Hearing of Submissions'. Ten minutes has been allocated for each submission. This includes time for the presentation and clarifying questions from Councillors. Council has resolved to consider and determine all the submissions received at a Special Meeting of Council scheduled at 11.00am on Wednesday 29 May 2019.

#### RECOMMENDATION

That Council hear the following submissions on Council's Proposed 2019-2022 Rating Strategy as prescribed under s.223 of the Local Government Act 1989, as follows:

- a. Ralph Gallagher Questions the process, the new categories, taxation, rate capping, and necessary information for ratepayers;
- b. Barry Gilbert Reduce the Rural Vacant Land rate from 190 per cent to 140 per cent;
- c. Marie Gerrard-Staton (Rate Challengers A Community South Gippsland Group) – requests monthly meetings around the shire to discuss rates, that a representative panel be created to provide input into the Rating Strategy, that Councillors attend meetings to be educated about rates, requests a rates waiver for pensioners, the elderly and the disabled; and requests removal of the Rural Residential rate;
- d. Cheryl Denman Rate increases have become unsustainable and do not take into account the financial hardship experienced by all ratepayers, particularly pensioners; and

e. Phil Rerden (Foster Chamber of Commerce) – Reduce the differential on Commercial and Industrial Properties from 105 per cent to 100 per cent. The Rural Residential Rate is contentious.

#### **REPORT**

#### **Background**

Submissions to the Proposed 2019-2022 Rating Strategy closed at 5.00pm on 26 April 2019. Seven submissions were received through the formal s.223 public exhibition process.

Five submitters have indicated that they wish to speak to their submissions. These submitters are listed in the attached summary together with the time of their presentation and a copy of their submission (**Attachment [2.1.1]**). The Special Meeting commences at 2.15pm. The presentations will provide Councillors with an opportunity to ask questions and seek further clarification from the submitters.

Council will formalise its decision on the s.223 submissions at a Special Meeting of Council to be held on 29 May 2019 at 11.00am.

#### CONSULTATION

Council has undertaken a formal s.223 public participation process to inform the Proposed 2019-2022 Rating Strategy which was endorsed by Council on 20 March 2019.

The formal consultation process commenced on Tuesday 26 March 2019 and concluded at 5.00pm on Friday 26 April 2019. The community was invited to make formal submissions on the Proposed 2019-2022 Rating Strategy and to indicate if they wished to speak to their submission.

#### **RISKS**

Hearing from submitters that have indicated a desire to speak to their submission is a legal requirement associated with the s.223 public engagement process. Holding a Special Meeting of Council to consider and determine the outcome of submissions will complete the process on 29 May 2019.

Adherence to these formal requirements has mitigated Council's risks of (i) potentially making uninformed decisions, (ii) denying people natural justice to participate in decisions likely to affect them, or (iii) breaching the Local Government Act 1989.
