



A Child Friendly South Gippsland

We believe in a South Gippsland where what we do and the spaces we provide consider the needs of children. In a child friendly South Gippsland, children's voices and opinions are taken into consideration and influence decision making processes. Children's rights are reflected in policies, laws, programs and budgets.





Introduction

South Gippsland Shire Council and its partners are committed to improving the outcomes for children and families by working in partnership with the community, service providers and local businesses.

Children and Families – A plan for the future in South Gippsland 2016 – 2021 (the Plan) builds on the work of the previous Municipal Early Years Plan 2011 – 2015 and will be supported by:

- An annual implementation plan providing details of projects and actions towards achieving outcomes of this plan.
- Annual reporting against the projects and actions.
- Monitoring on outcomes every five years.

Purpose of this plan

The plan focuses on partnerships between local agencies, levels of government, children and families, and the wider community to improve outcomes for children aged 0 - 8 years in South Gippsland.

It is supported by a shared vision between agencies working with children and families in South Gippsland. The strategic direction of this plan will be incorporated into detailed implementation plans and service plans resulting in a collective impact approach.

What the research tells us

Overwhelming evidence indicates the first years of a child's life are critical to healthy development.

Early childhood is a time when a child's brain is developing rapidly. The evidence shows that positive, healthy development is critical for setting foundations for lifelong learning and wellbeing.

Engagement with high quality early years services for children and families supports this development with positive outcomes over the long term.

Healthy development depends on the quality and reliability of a young child's relationships with the important people in their life, both within and outside the family. Support to families and caregivers helps build a strong foundation for the child. Stressful events can impact child development, health, social competence and ability to succeed in school and life. Research indicates that providing extra support for vulnerable families and appropriate early intervention are ways to break the cycle of disadvantage.


Children's rights are influenced and impacted by their everyday experiences - where they play, how they learn, who they live with, the information they access, and where they get help when they get sick.





Services for Children and Families

Health, education and care, early intervention and community services are available within South Gippsland. Services, including parent support programs, public dental health and paediatrics, require families to travel outside the Shire.

South Gippsland Shire Council provides services to children and families including Maternal and Child Health, Immunisation, Supported Playgroups, Library and Preschool Inclusion.

How we developed the Plan

The plan was developed in consultation with children, families and services providers in South Gippsland. Using surveys, drawings, interviews and discussions our community informed us about what would make South Gippsland more child friendly.

'Children learn in the context of their families and community. Throughout the early years children acquire knowledge and skills that form the foundations of their later achievement. They learn how to learn and they develop dispositions for learning and a sense of agency. They make decisions and choices, to influence events and to have an impact on their world'

Monitoring and reporting on our progress

An annual report will be provided to Council, plan partners and relevant government departments. The final review will consider the extent to which the outcomes have been achieved through the actions of the plan and other influencing factors.

The final review will inform the development of the next Early Years Plan for children and families in South Gippsland.


