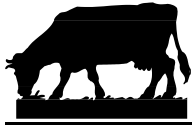

**APPEAL – NAMING ROADS**  
**SOUTH GIPPSLAND SHIRE – MCILLWAINE STREET- SECTION 2**

We believe that the naming of our road needs some discussion. We were informed by South Gippsland Shire our road was to be renamed and supplied a list of possible names. We may have missed it but do not recall any voting required on the short list supplied from Shire.

We did put forth the suggestion of Livingstone Lane as our neighbours have large property adjoining us although their property is listed on Morgans Road, on which they farm.

Our neighbours –the Livingstone's - suggested Rosella Lane (or Rise) which after some thought is preferable to us. Our road finishes at our property then turns into a walking track which has large numbers of rosellas, parrots and abundant other wildlife.

We and the Livingstones are the major owners of land on this section. The Livingstone's have only slightly more frontage. (approx. 100mt)

We hope you will consider this proposal to rename section 2 of McIllwaine Street to Rosella Lane (or Rise).
