2.1. 223 SUBMISSION HEARING - FISH CREEK QUARRY PROPOSED LEASE

Infrastructure Directorate

EXECUTIVE SUMMARY

Council owns several parcels of land at the end of Fish Creek Quarry Road, Fish Creek which is currently leased to Goldsmith Quarries Pty Ltd (Goldsmith) for use as a quarry. The lease expires on 30 June 2018.

At the Ordinary Meeting of Council held 20 December 2017, resolved to commence the statutory procedures in accordance with ss.190 and 223 of the Local Government Act 1989 to enter into a lease of the Fish Creek Quarry being part of CP165852 with an approximate area of 24.5Ha to Goldsmith for an initial term of ten (10) years with options of two (2) further terms of five (5) years each for a rental and royalties amount to be determined by a specialist quarry valuer (the proposal).

Council published the notice calling for submissions in the local newspapers in the week commencing 8 January 2018 and Council received three submissions. Of the three submissions, one submitter has elected to be heard in support of their submission (**Confidential Attachment [15.1.1]** - Fish Creek Quarry Submission).

This report has been prepared for the Special Committee of Council comprising of the Mayor (who will chair the meeting), not less than two other Councillors, and the Director Infrastructure (for administrative purposes) to hear the submitter speak to their submission.

All submissions will be considered and determined at the Ordinary Meeting of Council to be held 28 March 2018 in an open session.

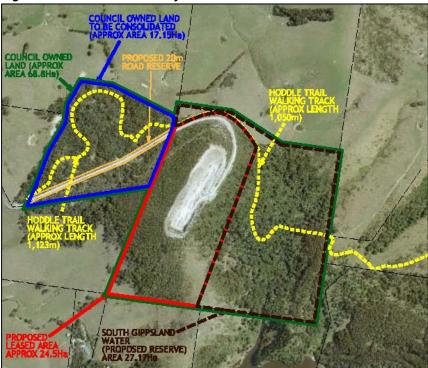
REPORT

Council owns several parcels of land (outlined in green in **Figure 1** below) at the end of Fish Creek Quarry Road, Fish Creek on which a quarry is located. All of the land is currently leased to Goldsmith Quarries Pty Ltd (Goldsmith) for use as a quarry. Goldsmith has a planning permit and the necessary work authority to operate the site as a quarry.

The lease commenced in 1998 with an expiry date of 2008 and was extended by exercise of options to 30 June 2018 when the lease expires. The lease has been transferred between different operators over time.

A plan is available in **Figure 1** below and a larger version in **Attachment (2.1.1]).**





The current leased area includes land that falls within the Battery Creek Catchment overlay, areas of native vegetation that can't be quarried, and part of the Hoddle Mountain Trail.

Council resolved at its ordinary meeting 20 December 2017 to reduce the leased area by excluding the Battery Creek Catchment area and access track, areas that can't be quarried, and part of the Hoddle Mountain Trail, whilst leaving sufficient area necessary for a quarry operations into the future. It also resolved to create the road reserve shown in **Figure 1** to provide a legal point of access.

CONSULTATION

Consultation in regards to the proposed lease has occurred as follows:

- Goldsmith current tenant and operator of the quarry. Goldsmith is interested in continuing with a lease over the land.
- Russell Kennedy lawyers legal advice and preparation of the lease (Confidential Attachment [15.1.3]).
- Planning department planning permit.
- South Gippsland Water Corporation confirmed agreement in principal to have the catchment area (highlighted black) vest with the Corporation and that the walking trail could continue.

- Earth Resources Regulation, Department of Economic Development Jobs Transport & Resources (DEDJTR) – regarding work plan and works authority.
- C J Ham & Company for valuation (Confidential Attachment [15.1.2]).
- Public Notice Council published the notice calling for submissions in the local newspapers edition week commencing 8 January 2018 on the proposal in accordance with s.223 of the Local Government Act 1989 to commence a public consultation process inviting written submissions to the proposal from the community by 5:00pm, Tuesday 6 February 2018.
- Submissions Council received three submissions in response to this
 public notice. Of the three submissions one submitter has elected to be
 heard in support of their submission (Confidential Attachment [15.1.1]).

OFFICER RESPONSE TO WRITTEN SUBMISSION

Mr Tim Farrell is to be heard by the Special Committee on behalf of the Fish Creek Farrell Family and Yuulong Nominees Pty Ltd.

Council is aware of the significant flora and fauna values present at the site including the presence Gippsland Mallee, *Eucalyptus kitsoniana*. The area to the of west and south of the current extraction limits has been specifically excluded from future development due to the significance of the vegetation and the habitat it provides for native fauna.

Council is also transferring ownership of approximately 27 ha of the site to South Gippsland Water (area east of the quarry). Approximately 92 percent of this area contains indigenous vegetation.

The land transfer is being undertaken to:

- protect the flora and fauna of the area;
- enable the Hoddle Mountain Trail to be further developed for passive recreation;
- protect the landscape/visual amenity of the area (Hoddle Range);
- protect and maintain water quality and quantity in the Battery Creek,
 Catchment (Fish Creek Reservoir); and
- minimise erosion (through the retention of the indigenous vegetation).

The remaining areas outside of the proposed lease site (existing quarry) will also be managed to protect flora and fauna values and enable the development of the Hoddle Mountain Trail as previously indicated.

Management will include weed control and upgrading, and clearly define the Hoddle Mountain Trail.

Management of the existing quarry is via the work authority issued by the DEDJTR. The quarry operator is required to prepare a work plan, which is endorsed and regulated by the DEDJTR. The work plan addresses a range of management issues including impacts to the:

- hydrogeology of the area;
- local flora and fauna; and
- rehabilitation (including an appropriate bond).

If Mr Farrell wishes to lodge a complaint regarding non-compliance onsite in respect of the work authority, work authority conditions, or the current approved work plan, he can do so by contacting Earth Resources, DEDJTR.

RESOURCES

Current rent is \$14,041 plus GST per annum, plus payment of royalties on sales of rock to Council and other purchasers.

Rental and/or royalties as per independent valuation.

Management of lease.

RISKS

The risks to Council if the quarry operations cease are:

- a reduction in supply of road making material for rural purposes;
- a loss of Council revenue; and
- remediation of the site by the quarry operator will become Council responsibility.

If a lease is not granted, the planning permit and works approvals cannot be approved.
