1.7. DECLARATION OF CONFLICT OF INTEREST FOR COUNCILLORS

- Complete a disclosure of interest form prior to the Meeting (forms are available from Council Business Department at South Gippsland Shire Council).
- Advise the Chair of the interest immediately before the particular item is considered (if attending the Meeting).
- Leave the Council Chamber or Meeting room while the item is being discussed and during any vote taken (if attending the Meeting).

The Councillor or staff member will be advised to return to the Council Chamber or Meeting room immediately after the item has been considered and the vote is complete.

Councillors should check the Minutes of the Council Meeting to ensure their disclosure is recorded accurately. Councillors are not required to disclose conflict of interest in relation to matters only considered at Meetings they do not attend. Detailed information is available in *Conflict of Interest – A Guide for Councillors – October 2012.*

EXECUTIVE SUMMARY

At the Special Meeting of Council on 21 March 2018, Council endorsed the Proposed Annual Budget 2018/19 (Proposed Budget) and the Revised Council Plan 2017-2021 (Revised Council Plan), including the four year Strategic Resource Plan and 2018/19 Annual Initiatives, and invited submissions from the public under s.223 of the Local Government Act 1989.

Fourteen submissions were received, with nine submitters requesting to speak at this Open Hearing. The attachment contains the nine submissions that will be heard on 23 May 2018 at 10.45am (Attachment [2.1.1]).

This Special Meeting is a formal 'Hearing of Submissions'. The purpose of this Special Meeting is for Council to hear from speakers in support of their written submissions (Attachment [2.1.1]). Ten minutes has been allocated for each submission. This includes time for the presentation and clarifying questions from Councillors. Council has resolved to consider and determine all the submissions received at a Special Meeting of Council scheduled at 11.00am on Wednesday 30 May 2018.

REPORT

Background

The Revised Council Plan 2017-2021 and Proposed Annual Budget 2018/19 were endorsed by Council on 21 March 2018.

A formal s.223 Public Engagement process has been undertaken. Submissions to the Revised Council Plan and Proposed Budget closed at 5.00pm on 26 April 2018 with fourteen submissions received.

Nine submitters have indicated that they wish to speak to their submissions. These submitters are listed in the attached summary together with the time of their presentation and their submission (Attachment [2.1.1]). The presentations will provide Councillors with an opportunity to ask questions and seek further clarification from the submitters to inform their decisions.

Council will formalise its decision on the s.223 submissions at a Special Meeting of Council to be held on 30 May 2018 at 11.00am.

CONSULTATION

Community feedback informed the development of the Revised Council Plan and Proposed Budget. Part of this feedback was gathered through a series of community engagement activities undertaken in February 2018. Other feedback has been considered from a range of sources throughout the year. Councillors considered this feedback at a Strategic Briefing on 21 February 2018.

Council is required under s.125 and s.129 of the Local Government Act 1989, to undertake a formal s.223 Public Participation process to inform the Revised Council Plan and Proposed Budget prior to their adoption.

A formal consultation process commenced on Tuesday 27 March 2018 and concluded at 5.00pm on Thursday 26 April 2018. The community was invited to make formal submissions on the Revised Council Plan and the Proposed Budget. In their submissions they could indicate if they wished to speak to their submission. The Special Meeting is an Open Hearing provided for the nine submitters who indicated they wanted to speak to Council in support of their submission.

RESOURCES

Council is requested to consider the financial implications arising from the submissions as it formulates the final Annual Budget 2018/19 and Revised 2017-2021 Council Plan for adoption at the Ordinary Meeting of Council 27 June 2018.

RISKS

Hearing from submitters that have indicated a desire to speak to their submission, is a legal requirement associated with the s.223 public engagement process. Considering and determining the outcome of submissions is a further legislated requirement under s.223.

A Special Meeting of Council has been scheduled on 30 May 2018 to complete the formal consultation process. Adherence to these formal requirements has mitigated Council's risk of potentially making uninformed decisions, denying people natural justice to participate in decisions likely to affect them or breaching the Local Government Act 1989.
